SCOPE AND CONTENT STATEMENT

The collection contains session minutes and Sunday School minute and records of the Clay City Presbyterian Church. The second series of documents are records of the Christian Endeavor Circle, which was a good will society comprised of members of the Clay City church.

BIOGRAPHICAL STATEMENT

Based on the records of this collection the Clay City Presbyterian Church and the Christian Endeavor Circle were organized on Apr. 20, 1895. Clay City is located in Clay County, Indiana in the midwestern side of the state near the Illinois border.

PROVENANCE

Since Hanover College's roots are in Presbyterianism, many records throughout Indiana have been donated at various times to the Presbyterian Archives of Hanover College.

RESTRICTIONS AND PERMISSIONS

The records of the Presbyterian Archives are on deposit at Hanover College and according to the Book of Order (G-9.0406), Hanover College may only hold official records on deposit. All ownership rights to the records remain with the creators of the records (the local church), or in the case the church no longer exists, the presbytery owns the records or the successive church body.

Permission to publish whole documents from the collection, or publication of these materials on the Internet, or any electronic environment, requires a written proposal and permission by the owner of the records.
