SCOPE AND CONTENT STATEMENT

The records of the Alexandria 1st Presbyterian Church include session minutes, congregational minutes, correspondence, and legal papers regarding the closure of the church in 1953.

BIOGRAPHICAL STATEMENT

The Alexandria 1st Presbyterian Church was organized on Mar. 27, 1892. The church closed in Sep. 27, 1953.

PROVENANCE

The collection was donated to Hanover College on Sep. 15, 1886.

RESTRICTIONS AND PERMISSIONS

The records of the Presbyterian Archives are on deposit at Hanover College and according to the Book of Order (G-9.0406), Hanover College may only hold official records on deposit. All ownership rights to the records remain with the creators of the records (the local church), or in the case the church no longer exists, the presbytery owns the records or the successive church body.
