SCOPE AND CONTENT STATEMENT

The collections consists of session, congregational , deacon, official board, and Sabbath School minute books. Other records include treasurer's books, the Young People's Society of Christian Endeavor, a missionary society, and a guest register.

BIOGRAPHICAL STATEMENT

The Greenfield 1st Presbyterian Church was organized in April 1855 and is located in Hancock County, Indiana, which is in the central portion of the state.

PROVENANCE

Since Hanover College's roots are in Presbyterianism, many records throughout Indiana have been donated at various times to the Presbyterian Archives of Hanover College.

RESTRICTIONS AND PERMISSIONS

The records of the Presbyterian Archives are on deposit at Hanover College and according to the Book of Order (G-9.0406), Hanover College may only hold official records on deposit. All ownership rights to the records remain with the creators of the records (the local church), or in the case the church no longer exists, the presbytery owns the records or the successive church body.

Permission to publish whole documents from the collection, or publication of these materials on the Internet, or any electronic environment, requires a written proposal and permission by the owner of the records.
