## **SCOPE AND CONTENT STATEMENT**

The collection contains session minutes, financial records, deacons, trustees, Ladies Bible Class, and Women's missionary society minutes, and church registers.

## **BIOGRAPHICAL STATEMENT**

The Women's Missionary Society was organized in 1897. The church appears to have been dissolved in the early 1940s. The church is located in Marion County, Indiana.

## **PROVENANCE**

Since Hanover College's roots are in Presbyterianism, many records throughout Indiana have been donated at various times to the Presbyterian Archives of Hanover College.

## **RESTRICTIONS AND PERMISSIONS**

The records of the Presbyterian Archives are on deposit at Hanover College and according to the Book of Order (G-9.0406), Hanover College may only hold official records on deposit. All ownership rights to the records remain with the creators of the records (the local church), or in the case the church no longer exists, the presbytery owns the records or the successive church body.

Materials from the collection may be copied based on the policies and costs determined by the archives. Permission to publish whole documents from the collection, or publication of these materials on the Internet, or any electronic environment, requires a written proposal and permission by the owner of the records.
